QUALITATIVE ANALYSIS

The Bank's core capital as of 30 September 2022 was IDR 34.4 trillion, an increase compared to the core capital in the previous period. This was mainly due to the increase oher disclosed reserves from retained earnings.

The Bank's total capital as of 30 September 2022 was IDR 39.0 trillion, an increase compared to the total capital in the previous period. This is due to the increase in Tier 1 capital.

Total RWA increased in September 2022 to Rp 156.1 trillion in line with the increase in credit risk RWA. The increase in Total RWA caused the CET1 Ratio, Tier 1 Ratio & Total Capital Ratio to decrease. In September 2022 the Total Capital Ratio was at 25.01%.
